Late Payment: A service charge of 1.5% per month (which is an APR of 18%) will be charged to all past due accounts.

Collection and Legal Costs: By signing this credit application the applicant agrees that should collection or legal action become necessary to obtain payment for the credit purchases, all cost of collection, including, but not limited to, collection agency fees, reasonable attorney or other legal fees, court costs lien filing fees and any other collection costs will be paid by the customer.
